**Bid Evaluation Criteria (BEC)**

**Technical Criteria (as a single bidder)**

The bidder must be a regular manufacturer of compressor block, packager and supplier of Electric Motor Driven CNG Compressor Package. The bidder shall have the single point responsibility for manufacturing / packaging, supplying, installing and commissioning of 1700 SCM Electric Motor Driven CNG Compressor Package.

The bidder, in the previous seven (07) years from the due date of submission of bid, shall have designed, engineered, manufactured/ packaged, tested, supplied and commissioned to any CGD firm at least 1 no. CNG Motor Driven compressor package of 1700 SCM capacity suitable for operation at suction pressure in the range of 34 - 45 bars, discharge pressure of 250 bars, from the proposed facility of manufacturing & this package should have completed continuous trouble free operation for minimum 3000 HRS without any major break down as on the bid due date. The compressor block proposed in the bid shall be of same make and model as used in this CNG Motor Driven compressor package.

The bidder directly or through their authorized agencies, should have provided Operation & Maintenance services to at least 1 No. CNG Motor Driven Compressor Package of 1700 SCM capacity for a period of not less than one year. The period for trouble free operation & maintenance services shall be in the last seven years from the due date of submission of bid.

The bidder should have experience of having successfully carried out and completed similar work during the last 7 years from the due date of submission of bid.

### Similar Work Definition: -

**The bidder should have Designed, Engineered, Manufactured, Tested, Supplied and Commissioned to any CGD firm including Operation & Comprehensive Maintenance for Electric Motor Driven Compressors package of 1700 SCMH capacity.**

### Note: -

Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority constituted by the Department for Promotion of Industry and Internal Trade (DPIIT). Indian agents of such entities will also be eligible to bid only if the principal entity is registered with the Competent Authority.

### NOTE:

A job executed by a bidder for its own plant/ projects cannot be considered as experience for the purpose of meeting the requirement of BEC of this tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding Company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice (s) duly certified by Statutory Auditor/ Chartered Accountant of the bidder towards payments of statutory tax in support of the job executed for Subsidiary/ Fellow subsidiary/ Holding company. Such bidders to submit these documents in addition to the documents specified in the bidding document to meet BEC.

Copy(s) of Purchase/ Work order including a detailed scope of work along with its completion certificate from the concerned authority duly certified/ attested by the **Chartered Engineer and Notary Public** with legible stamp with original attestation along with the bid to meet the above technical criteria.

### **Financial Criteria (as a single bidder)**

Annual Turn Over of the bidder should be a minimum of ₹ 1,34,68,815.00 in any one of the preceding three financial years.

Net worth of the bidder should be positive as per the last audited financial statement.

Working Capital of the Bidder should be a minimum of ₹ 26,93,763.00 as per last audited financial year.

**Annual Turnover** – In case the tenders having the bid closing date upto 31st December (or as amended from time to time by Government) of the relevant financial year, and audited financial results of immediate 3 preceding financial years are not available, the bidder has an option to submit the audited financial results of the 3 years immediately prior to that. Wherever the closing date of the bid is after 31st December (or as amended from time to time by Government) of the relevant financial year, bidder has to compulsorily submit the audited financial results for the immediate 3 preceding financial years.

**Net worth and Working Capital** –In case the tenders having the bid closing date upto 31st December (or as amended from time to time by Government) of the relevant financial year, and audited financial results of immediately preceding financial year is not available, in such a case the audited financial results of the year immediately prior to that year will be considered as last financial year for Net worth/ Working Capital calculation. Wherever the closing date of the bid is after 31st December (or as amended from time to time by Government) of the relevant financial year, bidder has to compulsorily submit the audited financial result for the immediately preceding financial year. If the bidder's working capital is negative or inadequate, the bidder shall submit a letter from their bank having net worth not less than ₹ 100 crores, confirming the availability of line of credit for at least working capital requirement as stated above. The line of credit letter from bank to be submitted strictly as per format at F-15

### (A) **Authentication of Documents to be Submitted in Support of BEC**

#### (i) **Technical Criteria of BEC**

All documents in support of Technical Criteria of BEC to be furnished by the Bidder shall necessarily be duly certified/ attested by Chartered Engineer and Notary Public with a legible stamp.

#### (ii) **Financial Criteria of BEC**

Bidder shall submit "Details of financial capability of Bidder" in the prescribed format (F-16) on CA's Letter Head duly signed and stamped by a Chartered Accountant. Further, a copy of audited annual financial statements submitted in the bid shall be duly certified/ attested by Notary Public with a legible stamp.

(B) Apart from the above, the Bidder must submit all other relevant documents/ information as specified in the Scope of Work/ SCC for Technical Evaluation of a bid or specified elsewhere in the Tender Document, towards proof of its responsiveness.

### **Methodology for Evaluation of Price Bids**

#### **Methodology for Evaluation, Comparison & Award**

Evaluation, Comparison and Award shall be done on overall L1 basis.

In case of a tie at the lowest bid (L1) position between two or more bidders, the order/ LOA will be placed on the bidder having higher/ highest turnover in last audited financial year
