**Bid Evaluation Criteria (BEC)**

**Technical Criteria (as a single bidder)**

The bidder should be a PESO approved Original Equipment Manufacturer (OEM) or packager or OEM authorised dealer of CNG Car/Auto Dispensers.

The bidder should have manufacturing/ fabrication/ packaging/ packaging facilities with adequate testing/ quality assurance facilities for CNG Car/Auto Dispensers.

Bidder should have designed, engineered, tested, supplied, installed and commissioned minimum Three (03) numbers of Car/ Auto dispensers for CNG application in a Single Order/ Contract during last Seven (07) years reckoned from bid due date.

Out of the above supplied dispensers, at least One (01) dispenser should have completed continuous trouble free satisfactory operations for not less than one year as on the bid due date.

A job executed by a bidder for its own plant/ projects cannot be considered as experience for the purpose of meeting the requirement of BEC of this tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding Company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by Statutory Auditor/ Chartered Accountant of the bidder towards payments of statutory tax in support of the job executed for Subsidiary/ Fellow subsidiary/ Holding company. Such bidders to submit these documents in addition to the documents specified in the bidding document to meet BEC.

2	Manufacturing/ Fabrication/ packaging facility	Copy of certificate from a reputed inspection agency such as CEIL/ Lloyds/ BV/ DNV/ TUV/ ABS/ Moody/ SGS/ GLI/ Velosi/ FCRI/ DVGW or equivalent stating that the proposed workshop facility has the capability for fabrication, assembly, & testing of the Quoted natural gas dispensers complying the specifications. The said certificate shall be valid as on the bid due date.
3	Experience	Copy of Purchase Order/ Letter of Award and its inspection certificates/ inspection release note (IRN)/ dispatch clearance/ final work completion certificate or satisfactory performance certificate as issued by the client establishing that the order has been executed. The execution proof(s) should have cross reference of Purchase/ LOA order number.
4	Satisfactory Performance	The confirmation letter/ certificate from client/ end user (with cross reference of PO) for satisfactory operation of one year.

**NOTE:**

A job executed by a bidder for its own plant/ projects cannot be considered as experience for the purpose of meeting the requirement of BEC of this tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding Company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice (s) duly certified by Statutory Auditor/ Chartered Accountant of the bidder towards payments of statutory tax in support of the job executed for Subsidiary/ Fellow subsidiary/ Holding company. Such bidders to submit these documents in addition to the documents specified in the bidding document to meet BEC.

Copy(s) of Purchase/ Work order including a detailed scope of work along with its completion certificate from the concerned authority duly certified/ attested by the **Chartered Engineer and Notary Public** with legible stamp with original attestation along with the bid to meet the above technical criteria.

**Financial Criteria (as a single bidder)**

Annual Turn Over of the bidder should be a minimum of ₹ 1,80,70,520.00 in any one of the preceding three financial years.

Net worth of the bidder should be positive as per the last audited financial statement.

Working Capital of the Bidder should be a minimum of ₹ 36,14,104.00 as per last audited financial year.

**Annual Turnover** – In case the tenders having the bid closing date upto 31st December (or as amended from time to time by Government) of the relevant financial year, and audited financial results of immediate 3 preceding financial years are not available, the bidder has an option to submit the audited financial results of the 3 years immediately prior to that. Wherever the closing date of the bid is after 31st December (or as amended from time to time by Government) of the

relevant financial year, bidder has to compulsorily submit the audited financial results for the immediate 3 preceding financial years.

**Net worth and Working Capital** –In case the tenders having the bid closing date upto 31st December (or as amended from time to time by Government) of the relevant financial year, and audited financial results of immediately preceding financial year is not available, in such a case the audited financial results of the year immediately prior to that year will be considered as last financial year for Net worth/ Working Capital calculation. Wherever the closing date of the bid is after 31st December (or as amended from time to time by Government) of the relevant financial year, bidder has to compulsorily submit the audited financial result for the immediately preceding financial year. If the bidder's working capital is negative or inadequate, the bidder shall submit a letter from their bank having net worth not less than ₹ 100 crores, confirming the availability of line of credit for at least working capital requirement as stated above. The line of credit letter from bank to be submitted strictly as per format at F-15

### **(A) Authentication of Documents to be Submitted in Support of BEC**

#### **(i) Technical Criteria of BEC**

All documents in support of Technical Criteria of BEC to be furnished by the Bidder shall necessarily be duly certified/ attested by Chartered Engineer and Notary Public with a legible stamp.

#### **(ii) Financial Criteria of BEC**

Bidder shall submit "Details of financial capability of Bidder" in the prescribed format (F-16) on CA's Letter Head duly signed and stamped by a Chartered Accountant.

Further, a copy of audited annual financial statements submitted in the bid shall be duly certified/ attested by Notary Public with a legible stamp.

**(B)** Apart from the above, the Bidder must submit all other relevant documents/ information as specified in the Scope of Work/ SCC for Technical Evaluation of a bid or specified elsewhere in the Tender Document, towards proof of its responsiveness.

### **Methodology for Evaluation of Price Bids**

#### **Methodology for Evaluation, Comparison & Award**

Evaluation, Comparison and Award shall be done on overall L1 basis.

In case of a tie at the lowest bid (L1) position between two or more bidders, the order/ LOA will be placed on the bidder having higher/ highest turnover in last audited financial year
