The bidder must have supplied minimum of 11 Nos. of Desktop & 02 Nos. of Laptop along with 02 years onsite comprehensive warranty from OEM or OEM's Authorized Dealer/ Distributors in a single order to Government Departments/ Organizations/ Public Sector Undertakings/ Private Sectors/ Multinational Corporation/ Company in previous 7 years to be reckoned from the final bid closing date

#### **Document Required for BEC**

**For OEM:** - Bidder must submit to submit Manufacturing License for supply of Desktop & Laptop in evidencing status self-attested of Authorised Signatory.

**For Dealer/ Distributor:** - Bidder must submit the Authorized Dealer/ Distributor/ certificate from OEM pertaining to supply of Desktop & Laptop duly certified/attested by notary public with legible stamp.

Bidder must submit copy(ies) of Purchase order/ contract along with its completion certificate/ execution certificate from the concerned authority or GST Invoices and relevant documents stating the completion of the order duly certified/ attested by **Chartered Engineer & Notary Public with Legible Stamp along** with bid in respect of their meeting the above technical criteria.
