Bid Evaluation Criteria (BEC)

<u>Technical Criteria (as a single bidder)</u>

The bidder shall be the manufacturer or an Authorized Distributors/ Dealer of $\frac{1}{2}$ " Brass Ball Valve

For Manufacturer: Bidder must submit valid documentary proof Company Registration Certificate/ ISO Certificate, NSIC Certificate etc. evidencing status of manufacturer of ¹/₂" Brass Ball Valve duly certified/attested by notary public with legible stamp

For Dealer/ Distributor: Bidder must submit the copy of Authorized Dealer/ Distributor/ Certificate with validity from the Manufacturer of "½" Brass Ball Valve" duly certified/attested by notary public with legible stamp

The bidder must have supplied a minimum of 7,500 Mtrs. of ¹/₂" Brass Ball Valve in a single order/ contract in a year in any of previous 7 years to be reckoned from the final bid closing date to any of the CGD entity approved by PNGRB.

The Bidder must submit Chemical Composition Test Reports of their samples from any of the NABL approved Labs duly certified by Chartered Engineer & Notary Public with Legible Stamp. The test report should clearly specify the Name of Bidder and Manufacturer of the ¹/₂" Brass Ball Valve

Documents Required

Bidder must submit copy(ies) of Purchase order/ contract along with its completion certificate/ execution certificate from the concerned authority or IN, Tax Invoices, LR Copies, E-way Bills and relevant documents stating the completion of the order; duly certified/ attested by Chartered Engineer & Notary Public with Legible Stamp along with bid in respect of their meeting the above technical criteria. <u>Financial Criteria</u> (as a single bidder)

Technical Criteria of BEC

All documents in support of Technical Criteria of BEC to be furnished by the Bidder shall necessarily be duly certified/ attested by Chartered Engineer and Notary Public with a legible stamp.

Apart from the above, the Bidder must submit all other relevant documents/ information as specified in the Scope of Work/ SCC for Technical Evaluation of a bid or specified elsewhere in the Tender Document, towards proof of its responsiveness.

Bidder not meeting any of the above-mentioned BEC shall be rejected without assigning any reason whatsoever. VGL's decision in this regard shall be final and binding on the bidder.

Additional Important Documents to be submitted:

Certificate for Undisputed Statutory Liabilities [Along with the Techno–Commercial Bid] "Bidder should not have any pending/ outstanding undisputed statutory liabilities (including GST, PF, ESIC, Service Tax, etc.) on the balance date for a period of more than 06 months as per audited financial statements of F.Y. 2022-23."

In support of the same, bidder shall have to submit a letter from its Chartered Accountant/ Internal Auditor/ Statutory Auditor (as applicable) on their letter head certifying the above.

Methodology for Evaluation, Comparison & Award

Evaluation, Comparison and Award shall be done on overall L1 basis.

In case of a tie at the lowest bid (L1) position between two or more bidders, the order/ LOA will be placed on the bidder having higher/ highest turnover in last audited financial year
