1	<p>Refer to BID_DOC (SCC): Clause 5.0 Payment Terms of 5.7 The prices/ rates shall remain firm till the expiry of the Contract and shall not be subjected to any escalation except</p> <ul style="list-style-type: none">• This above means that there will not be any payments against differential wages (Min. Wages notification during contract tenure), which can lead to an extra monetary burden for total of 6 instances (In 3 years) for wage escalation to be paid. Therefore, there may be chance of cutting on manpower (DSM) to cope up with wages escalation burden, which any agency would do.• Therefore, we request your kind to please have some mechanism or fix value/percentage for no extra payment for wages escalation. If minimum wages rise beyond fix value/percentage then only differential wages must be paid to cover monetary burden	Tender Conditions Prevail.
2	<p>Technical Criteria (As A Single Bidder):</p> <p>1.1 The bidder shall have completed/executed one single work order/ contract of "similar work" having sold/dispensed at least 11,35,341 kilograms of CNG per annum issued by only Indian companies directly involved in City Gas Distribution business in previous seven years to be reckoned from the final bid closing date.</p> <p>1.2 Bidder must submit, copy(s) of work order/ contract including detailed scope of work along with its completion certificate/execution certificate from the concerned authority, duly certified/attested by the Chartered Engineer and Notary Public with legible stamp along with bid, respect of their meeting the above technical criteria.</p> <p>We have JMR Reports with client signs and stamps to validate the Technical Criteria data of having sold/dispensed at least 11,35,341 kgs of CNG along with work orders documents. In the completion certificate value (amount) of work order carried out has been mentioned but amount of gas sale is not mentioned. So can we provide JMR reports with client attestations as a proof for the technical criteria?</p>	Tender Conditions Prevail.
3	<p>Financial Criteria (As A Single Bidder):</p> <p>2.3 Working Capital of the Bidder should be a minimum of ₹ 16,52,300.00 as per last audited financial year.</p> <p>Our working capital for the financial year 2021-2022 is ₹ 7,34,004 which is less than the required working capital as per the tender documents. It is our request that this criteria be relaxed, and we ask for a minimum working capital requirement of ₹ 7,00,000.</p>	Tender Conditions Prevail.
